NOTICE OF CLASS ACTION SETTLEMENT

**Current and Former Employees of Taconic Biosciences, Inc. may be eligible for a payment from a class action settlement**

*A New York State Court authorized this notice. You are not being sued. This is not a solicitation from a lawyer.*

A Settlement has been reached in a class action lawsuit alleging that Taconic Biosciences, Inc. (“Taconic”) experienced an unauthorized disclosure on or about January 30, 2017 of certain personally identifying information of present and former employees. The information disclosed included names, addresses, social security numbers, and 2016 income information. Plaintiffs allege that Taconic violated certain duties with respect to the personal data of employees and, as a result, W-2 data was sent to an unauthorized third party (the “Data Disclosure”). Taconic denies any wrongdoing and denies all claims asserted against it in the lawsuit. Both sides have agreed to settle the lawsuit to avoid the cost, delay, and uncertainty of litigation.

Your legal rights are affected whether you act or don’t act, so read this Notice carefully. You can read Plaintiffs’ Second Amended Complaint, the Settlement Agreement, other case documents, and obtain a claim form at [www.TaconicBiosciencesSettlement.com](http://www.TaconicBiosciencesSettlement.com).

**Who’s Included in the Settlement Class?** The settlement includes all current and former employees of Taconic whose W-2 data was compromised as a result of the Data Disclosure which occurred on or about January 30, 2017. **Taconic’s records show that you may have been affected by the unauthorized disclosure and may be entitled to recovery.**

**What Can You Get?** Class Members who submit a valid and timely Claim Form may be entitled to: (a) monetary relief for identity theft and reimbursement of certain expenses resulting from the Data Disclosure; and (b) 24 months enrollment in Experian’s IdentityWorks Credit Plus 3-Bureau identity theft protection service. The total amount of your claim depends upon the type of identity theft and losses you have experienced, the documentation you have for your claim, and any amounts previously paid to you by Experian’s ProtectMyID. The deadline to file your claim is **July 9, 2020**.

**Other Options.** If you do not want to be legally bound by the Settlement, you must exclude yourself by **May 9, 2019**. If you stay in the Settlement, you may object to it by **June 10, 2019**. The more detailed notice available at the website or by calling the number below explains how to exclude yourself or object. On **July 15, 2019**, the Court will hold a hearing on whether to approve the Settlement, Class Counsel’s request for attorneys’ fees of \$410,000, inclusive of reasonable costs, and an award of \$4,000 for the Class Representatives. You or your own lawyer, if you have one, may ask to appear and speak at the hearing at your own cost, but you do not have to. For more information, call or visit the website below.
